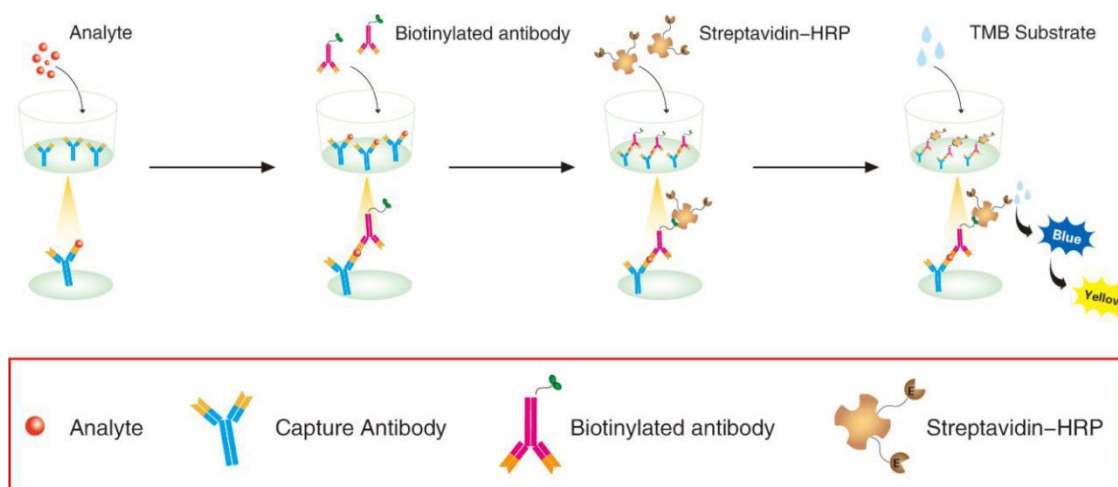
BACKGROUND

Interleukin-17F (IL-17F), also known as ML-1, is a member of the IL-17 family of cysteine knot cytokines which are involved in inflammation and tissue remodeling. IL-17F is secreted as a 45 kDa disulfide-linked homodimer and as an approximately 40 kDa disulfide-linked heterodimer with IL-17A (IL-17A/F). Mature mouse IL-17F shares 56% and 90% amino acid identity with human and rat IL-17F, respectively. IL-17F and IL-17A are co-expressed by the Th17 subset of activated CD4⁺ T cells as well as by mast cells, basophils, monocytes, and B cells. The expression of IL-17F is induced by IL-23 and can be suppressed by IL-17A. IL-17F binds and induces signaling through the widely expressed receptors IL-17 RA and IL-17 RC. These proteins form a ligand-induced receptor complex for IL-17A, IL-17F, and IL17A/F. IL-17 RC is required for signaling in response to all three cytokines. IL-17F triggers the production of multiple inflammatory cytokines from endothelial cells, epithelial cells, and keratinocytes. These inflammatory cytokines induce neutrophil infiltration and activation. IL-17A/F is less potent than the IL-17A homodimer at IL-17 receptor activation and more potent than the IL-17F homodimer. IL-17 family cytokines play a role in a number of inflammatory diseases such as rheumatoid arthritis, asthma, systemic lupus erythematosus, and allograft rejection. IL-17F is upregulated in allergic asthma and psoriasis, and it contributes to allergic inflammation and airway remodeling. IL-17F also promotes osteoclast and osteoblast maturation.

PRINCIPLE OF THE ASSAY

This assay employs the quantitative sandwich enzyme immunoassay technique. A monoclonal antibody specific for IL-17F has been pre-coated onto a microplate. Standards and samples are pipetted into the wells and any IL-17F present is captured by the coated antibody after incubation. Following extensive washing, a biotin-conjugate antibody specific for IL-17F is added to detect the captured IL-17F protein in sample. For signal development, horseradish peroxidase (HRP)-conjugated Streptavidin is added, followed by tetramethyl-benzidine (TMB) reagent. Following a wash to remove any unbound combination, and enzyme conjugate is added to the wells. Solution containing sulfuric acid is used to stop color development and the color intensity which is proportional to the quantity of bound protein is measurable at 450nm.

TECHNICAL HINTS AND LIMITATIONS

1. This Solarbio ELISA should not be used beyond the expiration data on the kit label.
2. To avoid cross-contamination, use a fresh reagent reservoir and pipette tips for each step.
3. To ensure accurate results, some details, such as technique, plasticware and water sources should be emphasized.
4. A thorough and consistent wash technique is essential for proper assay performance.
5. A standard curve should be generated for each set of samples assayed.
6. It is recommended that all standards and samples be assayed in duplicate.
7. Avoid microbial contamination of reagents and buffers. Buffers containing protein should be made under aseptic conditions and be prepared fresh daily.
8. In order to ensure the accuracy of the results, the standard curve should be made every time.

PRECAUTIONS

The Stop Solution suggested for use with this kit is an acid solution. Wear protective gloves, clothing, eye, and face protection. Wash hands thoroughly after handling.

OTHER SUPPLIES REQUIRED BUT NOT SUPPLIED

1. Microplate reader capable of measuring absorbance at 450 nm.
2. Pipettes and pipette tips.
3. Deionized or distilled water.
4. Squirt bottle, manifold dispenser, or automated microplate washer.
5. 500 mL graduated cylinder.

SPECIMEN COLLECTION & STORAGE

Cell Culture Supernates - Centrifuge cell culture media at 1000×g to remove debris. Assay immediately or aliquot and store samples at ≤ -20 °C. Avoid repeated freeze-thaw cycles.

Serum - Use a serum separator tube (SST) and allow samples to clot for 2 hours at room temperature or overnight at 2-8°C. Centrifuge approximately for 15 minutes at 1000×g. Assay immediately or aliquot and store samples at ≤ -20 °C. Avoid repeated freeze-thaw cycles.

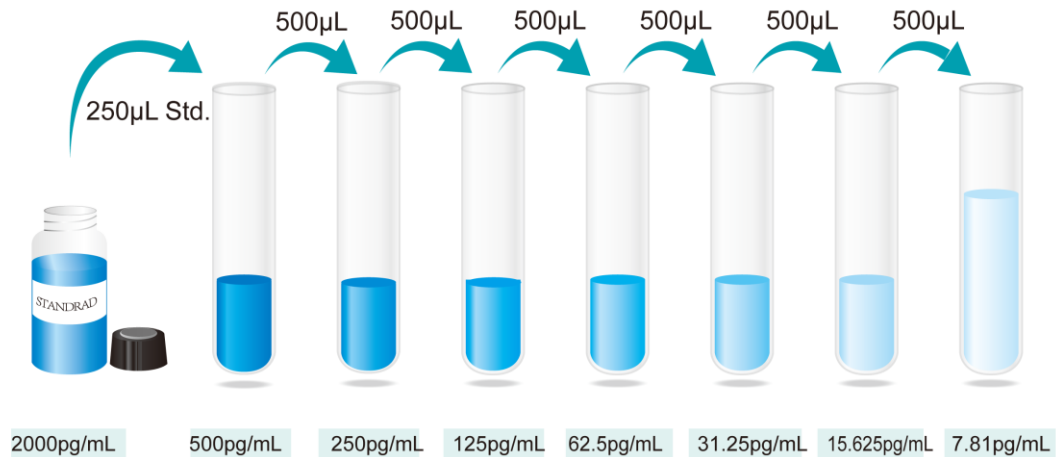
Plasma - Collect plasma using EDTA, heparin, or citrate as an anticoagulant. Centrifuge for 15 minutes at 1000×g within 30 minutes of collection. Assay immediately or aliquot and store samples at ≤ -20 °C. Avoid repeated freeze-thaw cycles.

Note: The normal rat serum or plasma samples are suggested to make a 1:2 dilution.

REAGENTS PREPARATION

1. **Temperature returning** - Bring all kit components and specimen to room temperature (20-25°C) before use.
2. **Wash Buffer** - Dilute 30mL of Wash Buffer Concentrate with 570mL of deionized or distilled water to prepare 600mL of Wash Buffer. If crystals have formed in the concentrate Wash Buffer, warm to room temperature and mix gently until the crystals have completely dissolved.
3. **Standard/Sample** - Reconstitute the Standard with 1.0mL of Standard/Sample Diluent. This reconstitution produces a stock solution of 2000pg/mL. Allow the standard to sit for a minimum of 15 minutes with gentle agitation prior to making dilutions. Pipette 250µL of Standard/Sample Diluent into 500pg/ml tube and the remaining tubes. Use the stock solution of 500pg/mL to produce a 2-fold dilution

series (below). Mix each tube thoroughly and change pipette tips between each transfer. The 500 pg/mL standard serves as the high standard. The Standard/ Sample Diluent serves as the zero standard (0 pg/mL).



Preparation of IL-17F standard dilutions

***If you do not run out of re-melting standard, store it at -20°C. Diluted standard shall not be reused.**

- Working solution of Biotin-Conjugate anti-rat IL-17F antibody:** Make a 1:100 dilution of the concentrated Biotin-Conjugate solution with the Biotin-Conjugate antibody Diluent in a clean plastic tube.

***The working solution should be used within one day after dilution.**

- Working solution of Streptavidin-HRP:** Make a 1:100 dilution of the concentrated Streptavidin-HRP solution with the Streptavidin-HRP Diluent in a clean plastic tube.

***The working solution should be used within one day after dilution.**

ASSAY PROCEDURE

Prepare all reagents and standards as directed. Wash the plate 3 times before assay.



Add 100µl standard or samples to each well, incubate 90 minutes,37°C.



Aspirate and wash 4 times

Add 100µl working solution of Biotin-Conjugate anti-rat IL-17F antibody to each well, incubate 60 minutes,37°C.



Aspirate and wash 4 times

Add 100µl working solution of Streptavidin-HRP to each well, incubate 30 minutes,37°C.



Aspirate and wash 5 times

Add 100µl Substrate solution to each well, incubate 15 minutes,37°C. Protect from light.



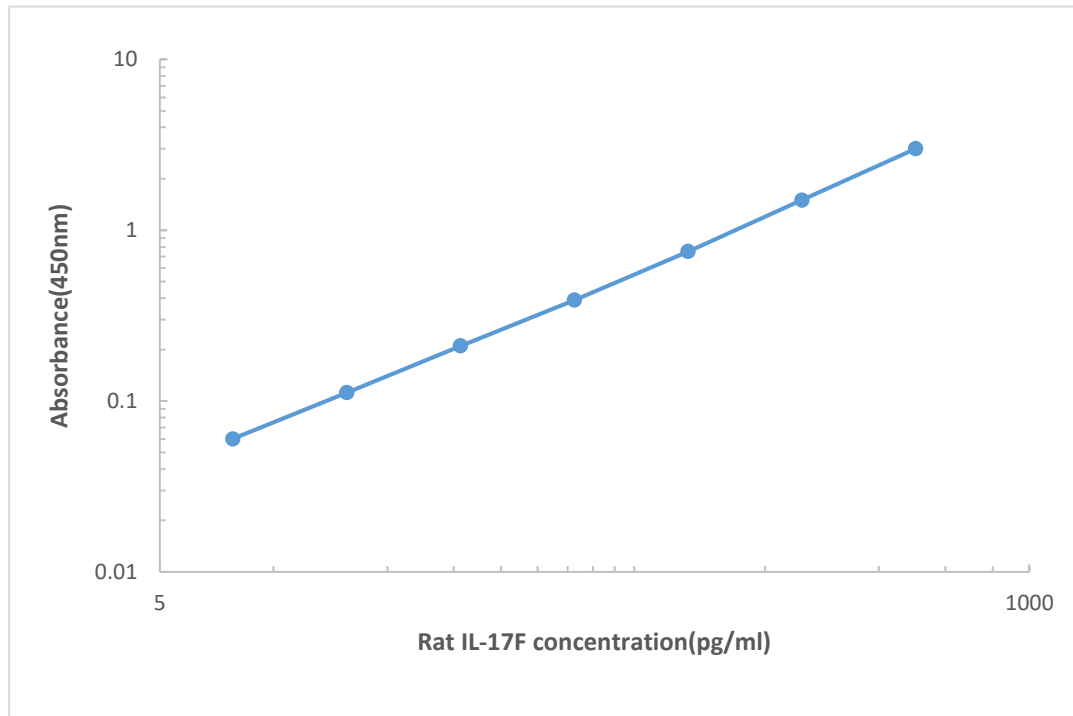
Add 50µl Stop solution to each well. Read at 450nm within 5 minutes.

CALCULATION OF RESULTS

1. The standard curve is used to determine the amount of specimens.
2. First, average the duplicate readings for each standard, control, and sample. All O.D. values are subtracted by the mean value of blank control before result interpretation.
3. Construct a standard curve by reducing the data using computer software capable of generating a four parameter logistic (4-PL) curve-fit. As an alternative, construct a standard curve by plotting the mean absorbance for each standard on the y-axis against the concentration on the x-axis and draw a best fit curve through the points on the graph.
4. The data may be linearized by plotting the log of the IL-17F concentrations versus the log of the O.D. and the best fit line can be determined by regression analysis. This procedure will produce an adequate but less precise fit of the data. If samples have been diluted, the concentration read from the standard curve must be multiplied by the dilution factor.
5. This standard curve is provided for demonstration only. A standard curve should be generated for each set of samples assayed.

Performance Characteristics

SENSITIVITY: The minimum detectable dose was 4pg/mL.

SPECIFICITY: This assay recognizes both natural and recombinant rat IL-17F. The factors listed below were prepared at 100ng/ml in Standard /sample Diluent and assayed for cross-reactivity and no significant cross-reactivity or interference was observed.

REPEATABILITY: The coefficient of variation of both intra-assay and inter-assay were less than 10%.

RECOVERY: The recovery of IL-17F spiked to three different levels in four samples throughout the range of the assay in various matrices was evaluated.

LINEARITY: To assess the linearity of the assay, three samples were spiked with high concentrations of IL-17F in various matrices and diluted with the appropriate Sample Diluent to produce samples with values within the dynamic range of the assay. (The plasma samples were initially diluted 1:1)
